

MINING SUPERVISOR S123

In Queensland, individuals in the mining industry who are appointed as supervisors or site safety and health representatives must hold the units of competency S123, also known as G189.

COURSE DESCRIPTION

This course is mandatory for mining industry supervisors. It meets the requirements for the position of Supervisor in the Resources Industry as per s.56 of the Coal Mining Safety and Health Act 1999 and s.51 of the Mining and Quarrying Safety and Health Act 1999 and is recognised by both the Coal Mining Safety and Health Advisory Committee and the Mining Safety and Health Advisory Committee.

The course comprises three units of competency, which have been specified by the Coal and Metalliferous Mining Safety and Health Advisory Boards for any person authorised to supervise workers in a mine. These competencies are required to be refreshed at least every 5 years as per Reg. 84 of the Coal Mining Safety and Health Regulation 2017 (Qld) – OHSa offers an online/distance learning option for this refresher option, which requires a brief theory assessment and portfolio of workplace evidence and activities to be submitted. Supervisors can choose to do the 5-day supervisor's package, which includes Standard 11, Mining Supervisor S123 and G2 over 5 consecutive days, Monday to Friday or Wednesday to Sunday.

COURSE REQUIREMENTS

Candidates should ideally already have recent experience working in resources and hold the worker level mining induction (i.e. Standard 11 Mining General Safety Induction).

STANDARD 11 UNDERGROUND MINING INDUCTION

This course covers both coal and metalliferous mines. The Standard 11 Mine Safety Induction (Underground) course is delivered face-to-face over one day. Upon successful completion of the written and practical assessments during the course, you will receive a Statement of Completion and a plastic Standard 11 Induction photo ID card enabling you to commence work on the mine site.

In addition to the training component of the mine induction, students will be required to complete a mine on-site verification workbook within 6 months of the training (check with the employer/mine as some only give 3 months) and return it to us with 3 tags and 3 personal risk assessments. On successful completion of the on-site verification workbook, students will be issued with a Statement of Attainment for the relevant unit of competency, in addition to their full ID card, which, at this stage, lasts for 5 years.

G2 RISK FACILITATOR

This 'G2' RIIRIS402E Carry out the Risk Management Processes course covers the skills and knowledge required to Carry out the Risk Management Processes in the Coal and Metalliferous mining industries. This competency is a statutory requirement according to mining legislation for certain occupational categories as deemed by the respective Mining Safety & Health Advisory Committees. Some mining companies have expanded which groups of people require this competency with some sites now requiring any person with a supervisory capacity to also hold this competency along with the Mining Supervisor S123.

This unit of competence supersedes the MNCG1002B – Implement and apply Risk Management Processes; commonly referred to as G2.

ICAM LEAD INVESTIGATOR TRAINING COURSE

The ICAM Incident Investigation method is quickly becoming the preferred method for investigating incidents on many major projects and is being identified as a required skill for WHS personnel.

The OHSA ICAM Incident Investigation Lead Investigator Course has been developed around the Incident Cause Analysis Method which has been developed in association with Professor James T Reason in his research on Human Error and its contribution to incidents.

DIPLOMA OF WORK HEALTH & SAFETY | ONLINE

Diploma of Work Health and Safety BSB51319 will provide students with a safety qualification, enabling the graduate to fulfil the role of WHS Officer/Supervisor or Manager in an organisation. This qualification builds on what students have learned in Certificate IV in WHS qualification.

Course pre-requisite: Students must have at least the five core units from BSB41419 Certificate IV in WHS or units deemed equivalent. See course requirements for more information.

This qualification is suitable for people who coordinate and maintain an organisation's Work Health and Safety (WHS) program. It also reflects the role of practitioners who apply a substantial knowledge base and well-developed skills in a wide variety of WHS contexts.

ONLINE WORKPLACE REHABILITATION & RETURN TO WORK CO-ORD. COURSE

This course is a combination of online and a phone chat/video conferencing with the course assessor.

This course is designed to provide an introduction to the management of injured workers in Queensland according to the Workers' Compensation and Rehabilitation Act 2003 QLD & Regulation 2014 QLD.

It is the responsibility of the employer to ensure their Rehabilitation and Return to Work Coordinator is appropriately qualified and competent to carry out their role as per S.226 of the Act. It is also the responsibility of the RRTWC that they understand the principles of managing injured workers with reference to the legislation and best practice injury management principles and is able to fulfill the Functions of a RRTWC as per Reg 114 of the Regulation.

HEALTH & SAFETY REPRESENTATIVE HSR

The HSR training course provides participants with the skills and knowledge to enable them to fulfill the role of Health and Safety Representatives (HSR) as set down in the NEW National Harmonisation legislation as detailed in section 72 of the Work Health and Safety Act 2011 and s.21 of the Regulation 2011. OHSA is licensed to deliver this government approved course. HSR's are then entitled to receive 1 day refresher training every 3 years. We can also deliver in-house courses on-site.
